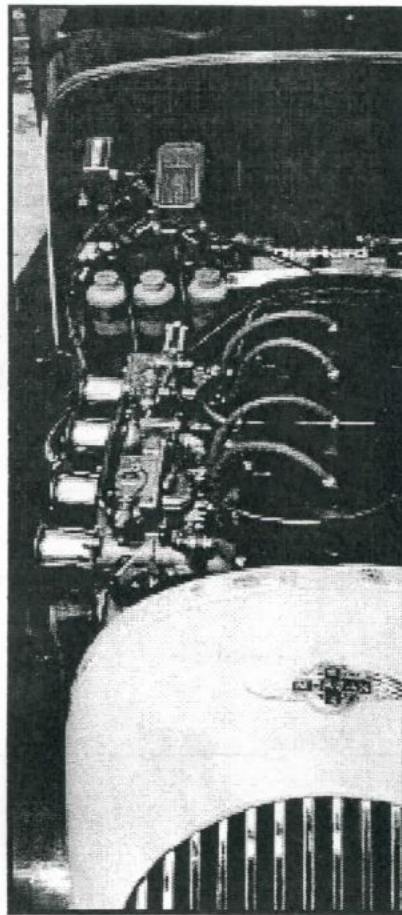

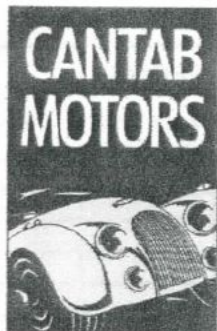

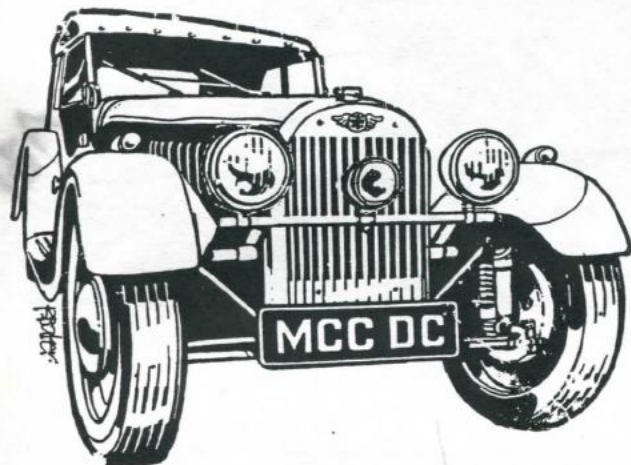

Correct running time for each leg:

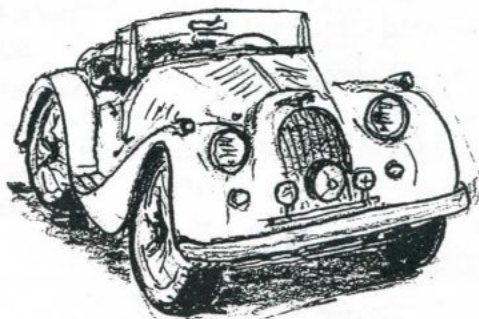
Leg 1 - 24 min 22 sec
